Success is in how your legacy lives on. Planning ahead is a great act of love for those to honour your wishes.

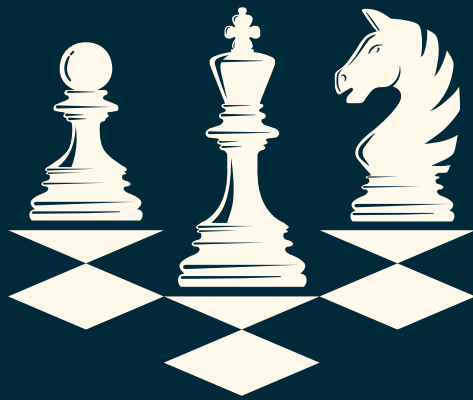
